**AGREED ORDER GRANTING DEFENDANT'S UNOPPOSED MOTION TO  
DETERMINE CONFIDENTIALITY OF COURT RECORDS—NOVEMBER 4, 2025  
ORDER DENYING DEFENDANT'S MOTION FOR SUMMARY JUDGMENT**

THIS CAUSE came before the Court on Defendant's, Jena M. Caldwell, Unopposed Motion to Determine Confidentiality of Court Records—November 4, 2025 Order Denying Defendant's Motion for Summary Judgment (the "Unopposed Motion"), and this Court, after reviewing the docket, including but not limited to the Unopposed Motion, and being otherwise duly advised, hereby **FINDS** and **ORDERS** as follows:

1. The Unopposed Motion is **GRANTED**, and the Clerk of Court is hereby directed to file and place this Court's November 4, 2025 Order Denying Defendant's Motion for Summary Judgment (the "Order Denying Summary Judgment") under seal.

2. In so ruling, pursuant to Rule 2.420(e)(4) of the Florida Rules of Judicial Administration, this Court finds that:

- a. This is a civil case;
- b. The grounds for determining information is confidential are Rule 2.420(c)(7) of the Florida Rules of Judicial Administration and this Court's prior June 24, 2025

Stipulated Confidentiality Order which makes any information marked as “Confidential” during discovery (including the personal financial information of Defendant) protected from disclosure;

c. This Court’s November 4, 2025 Order Denying Defendant’s Motion for Summary Judgment (the “Order Denying Summary Judgment”) inadvertently contains multiple references to private personal financial and compensation information attributed to Defendant that were obtained from documents and discovery answers produced and provided to Plaintiff by Defendant as “Confidential” pursuant to this Court’s June 24, 2025 Stipulated Confidentiality Order;

d. The only persons entitled to view “Confidential” information under the June 24, 2025 Stipulated Confidentiality Order are the parties, their attorneys, and this Court;

e. The degree, duration, and manner of confidentiality ordered herein are no broader than necessary to protect the interests set forth in Rule 2.420(c);

f. There are no less restrictive measures available to protect the interests set forth in Rule 2.420(c); and

g. The Clerk of Court is directed to publish the instant Order in accordance with Rule 2.420(e)(5).
