**ORDER GRANTING DEFENDANT'S *UNOPPOSED* MOTION

2. The License Agreement and Amendment that are referenced in the Motion and attached to the Complaint as exhibits, and the portions of the Complaint (at paragraphs 7, 10, 25, and 26) that contain excerpts of the License Agreement and Amendment, shall be sealed as confidential pursuant to Florida Rule of Judicial

Administration 2.420(c)(9) and exempt from public access and remain sealed until further order of this court.

3. The names of the parties need not be redacted or substituted.


4. The progress docket and similar records need not be deemed confidential.

5. In the Court record, this confidential information may be viewed by any judicial officer, judicial staff, court administrative staff, the parties and their counsel of record.

6. The Court finds that (i) the degree, duration, and manner of confidentiality ordered by the Court are no broader than necessary to protect the interests set forth in Florida Rule of Judicial Administration 2.420(c), and (ii) no less restrictive measures are available to protect those interests.

7. The Clerk of the Court is directed to publish this Order in accordance with Florida Rule of Judicial Administration 2.420(e)(5).
